PRIVACY POLICY

Last Updated and Effective Date: March 10, 2023

This Privacy Policy describes how Weldbend Corporation ("*Weldbend*," "*we*," or "*us*") collects, uses, and discloses personal information about you and your data privacy rights. Personal information is sometimes also referred to as personal data, personally identifiable information, or other like terms to mean any information that directly or indirectly identifies you or is reasonably capable of being associated with you or your household. This Privacy Policy applies if we collect personal information when you visit our website, contact us, conduct business dealings with us, request an account on our Material Traceability System, use our application, or when you otherwise interact with us (collectively, "*Services*").

Our Services are intended for business-to-business purposes only and not for consumers acting in a personal or household context. By using our Services, you acknowledge that you are a representative or agent of a business.

Source and Type of Personal Information We Collect

Information You Provide to Us

We collect personal information you provide directly to us. For example, we collect information directly from you when you register for our Material Traceability System or contact us for customer support or other inquiries. The types of personal information that we may collect directly from you includes certain identifiers and contact information, such as your name, company name, title, email address, physical address, phone number, and password. In addition, when you conduct business dealings with us, we may retain certain commercial information regarding records of the products or services you purchased, obtained, or considered, or other purchasing or consuming histories or tendencies. Further, when you purchase products from us, we may receive a physical copy of a check you provide for payment and wire instructions.

Moreover, when you visit our facilities, we may use audio, electronic, visual, or other similar information for security purposes.

Information We Collect Automatically

We automatically collect certain personal information about your interactions with us or our Services, including:

- **Device and Usage Information:** We may collect information about how you access our Services (*e.g.*, this website and use of our guest WiFi at our facilities), including data about the device and network you use, such as your hardware model, operating system version, mobile network, IP address, unique device identifiers, browser type, and app version. We also collect information about your activity on our website and guest WiFi, such as access times, pages viewed, links clicked, and the page you visited before navigating to our Services.
- Information Collected by Cookies and Similar Tracking Technologies: We and others that control collection of personal information may use tracking technologies, such as cookies, to collect information about you. Cookies are small data files stored on your hard drive or in device memory that help us improve our Services and your experience, see which areas and features of our Services are popular, and count visits. For more information about cookies and how to disable them, see the Your Choices section below.

Purpose and Use of Personal Information

We may use the categories of personal information identified above for the following purposes:

- Provide, maintain, and improve our Services;
- Conduct business dealings with you and our service providers;
- To send you information about our Services, updates in the industry, and other communications;
- Improve your experience on our website or mobile app;
- Respond to your comments and questions and provide customer service;
- Detect, investigate, and prevent security incidents and other malicious, deceptive, fraudulent, or illegal activity and protect the rights and property of Weldbend and others;
- Debug to identify and repair errors on our website and mobile app;
- Comply with our legal and financial obligations; and
- Carry out any other purpose described to you at the time the information was collected.

Disclosure of Personal Information

We disclose personal information in the following circumstances or as otherwise described in this policy:

• **Our Service Providers or Contractors:** We may disclose or make available personal information with our services providers and contractors who provide services to our business, such as cloud storage, shipping, IT and software, email, and analytics cookies.

- Legal Disclosures: We may disclose personal information if we believe that disclosure is in accordance with, or required by, any applicable law or legal process, including lawful requests by public authorities to meet national security or law enforcement requirements. We may also disclose personal information if we believe that your actions are inconsistent with our user agreements or policies, if we believe that you have violated the law, or if we believe it is necessary to protect the rights, property, and safety of Weldbend, our users, the public, or others.
- With Advisors and Lawyers: We may disclose personal information with our lawyers and other professional advisors where necessary to obtain advice or otherwise protect and manage our business interests.
- **Disclosure of Personal Information During Change of Ownership:** We may disclose personal information in connection with, or during negotiations concerning, any merger, sale of company assets, financing, or acquisition of all or a portion of our business by another company.
- With Your Consent: We may disclose personal information with your consent or at your direction.
- **Disclosure of Non-Personal Information:** We may disclose aggregated or de-identified information that cannot reasonably be used to identify you.

Retention of Personal Information

We store personal information for as long as necessary to carry out the purposes for which we originally collected it and for other legitimate business purposes, including to meet our legal, regulatory, or other compliance obligations.

Analytics

We may allow others to provide analytics services on our behalf across the web and in mobile apps. These entities may use cookies, web beacons, device identifiers, and other technologies to collect information about your use of our Services and other websites and applications, including your IP address, web browser, mobile network information, pages viewed, time spent on pages or in mobile apps, links clicked, and conversion information. This information may be used by us and others to, among other things, analyze and track data, determine the popularity of certain content, and better understand your online activity.

Transfer of Information to the United States and Other Countries

Weldbend is headquartered in the United States, and we have operations and service providers in the United States and other countries. Therefore, we and our service providers may transfer your personal information to, or store or access it in, jurisdictions that may not provide levels of data protection that are equivalent to those of your home jurisdiction. We will take steps to ensure that your personal information receives an adequate level of protection in the jurisdictions in which we process it.

Your Choices

Account Information

Communications Preferences

You may opt out of receiving promotional emails from Weldbend by following the instructions in those communications. If you opt out, we may still send you non-promotional emails, such as those about your account or our ongoing business relations.

Children

This website is not intended for or directed at children under the age of 18. In addition, we do not knowingly collect personal information from children under the age of 18. We also do not knowingly sell, share, use for targeted advertising, or disclose the personal information of children under the age of 18.

Selling or Sharing of Personal Information

We do not sell or share your personal information with third parties. We also do not knowingly sell, share, use for targeted advertising, or disclose the personal information of children under the age of 16.

Sensitive Personal Information

Under California law, certain types of personal information are considered "sensitive" personal information and requires additional data privacy rights and obligations. We only collect account

login information to provide access to the Material Traceability System, which may be considered sensitive personal information. We only use the account login information for certain limited and permitted purposes, such as to provide the goods or services you requested; prevent, detect, and investigate security incidents; resist malicious, deceptive, fraudulent, or illegal actions; and verify or maintain the quality of our Services. Because we use your sensitive personal information for these limited purposes, we do not offer a limit use and disclosure of sensitive personal information right under California law. Your Rights

The California Privacy Rights Act ("CPRA") affords California residents certain rights with respect to their personal information, subject to certain exceptions. Subject to certain limitations you have the following rights:

- (1) Right to Delete. You have the right to request us to delete the personal information we have collected about you.
- (2) Right to Correct. You have the right to request us to correct inaccurate personal information we maintain about you.
- (3) Right to Know and Access. You have the right to know and access the personal information we have collected about you, including the categories of personal information, the categories of sources from which the personal information is collected, the business or commercial purpose for collecting, selling, or sharing personal information, the categories of third parties to whom we disclose personal information, and the specific pieces of personal information we have collected about you.
- (4) Right to Data Portability. You have the right to receive the information under right (3) in a format, to the extent technically feasible, that is portable, usable, and allows you to transmit the personal information to a person without impediment, where the processing is carried out by automated means.
- (5) Rights Related to Sharing for Cross-Context Behavioral Advertising or Sale. "We do not share your personal information for cross-context behavioral advertising or sell your personal information. Please <u>Contact Us</u> below if you have any questions."
- (6) Rights Related to Sensitive Personal Information. As described in the <u>Sensitive</u> <u>Personal Information</u> section above, we only use your sensitive personal information for permitted purposes. As such, there is no need to exercise your right to limit the use or disclosure of sensitive personal information. Please <u>Contact Us</u> below if you have any questions.
- (7) Right to No Discrimination. You have the right not to be discriminated against for exercising any of your privacy rights. This includes us not: (a) denying you goods or services; (b) charging you different prices or rates for goods or services, including through the use of discounts or other benefits or imposing penalties; (c) providing you a different level or quality of goods or services; (d) suggesting to you that you will receive a different price or rate for goods or services or a different level or quality of goods or services; and (e) retaliating against you for exercising your privacy rights.

Instructions on How to Exercise Your Privacy Rights

In some instances, we will need to verify your identity before honoring your privacy right request. We will verify your identity by asking you to provide personal information related to your recent interactions with us. We will honor your privacy rights request within 45 calendar days of receipt, unless we request an extension as permitted by data privacy laws.

Authorized Agents

You may exercise your privacy rights through an authorized agent. If we receive your request from an authorized agent, we may ask for evidence that you have provided such agent with a power of attorney or that the agent otherwise has valid written authority to submit requests to exercise rights on your behalf. Additional Disclosure for California Residents

Do Not Track

Some browsers have incorporated "Do Not Track" features. Most of these features, when turned on, send a signal or preference to the websites you visit indicating that you do not wish to be tracked.
